1. **Civilian candidates, including existing ECHS employees, can apply** for posts reserved for Ex-Servicemen. However, Civilians will be engaged for maximum 11 months as per paragraph 4 of Annexure I to aforementioned Govt. Policy letter, if suitable Ex-Servicemen are not available. On open vacancies, duration of employment will be 12 months under Para 8 (d) and 14 (a) (iv) of aforesaid Policy Letter. (2) Contract is liable to be terminated by ECHS before expiry of contractual period, by giving 30 days notice/remuneration thereof, with no right for renewal or permanent absorption. (3). **Age Limit:** Candidates selected for the posts of OIC age-63 yrs, Medical Specialist & Medical Staff should not have attained the age of 66 years and Para Medical/Non Medical Staff the age of 53 yrs as on 01 May 2018 (4). Contract is liable to be terminated by ECHS before expiry of contractual period, by giving 30 days notice/remuneration thereof, with no right for renewal or permanent absorption. (5). Selection process comprises of interview. There is no UPSC/State PSC written test because posts are Contractual and Temporary. (6) Place, date and time of Interview will be intimated to eligible applicants telephonically, after scrutiny of applications. (7) Candidates to bring original educational certificate/degree/testimonials/experience certificate and two PP photographs for interview.
