**General terms and conditions of Recruitment of Non-Teaching posts (temporary)**

1. The candidates should submit their application along with Bio-Data and all relevant enclosures by hand or post along with Demand Draft of Rs. 500-00 (Rupees Five Hundred only) (Rs. 125 for SC/ST and at free of cost for PwD candidates) in favour of Registrar, Rashtriya Sanskrit Vidyapeetha Tirupati. Money orders or cheques shall not be accepted.
2. The filled in application should be addressed to “The Registrar, Rashtriya Sanskrit Vidyapeetha, Tirupati – 517 507 , A.P. in an envelope superscribing “APPLICATION FOR THE POST OF \_\_\_\_\_” and should reach this office on or before 5.30 p.m. on 25-05-2018.
3. Applications received after the due date shall be rejected.
4. The Vidyapeetha shall not be responsible for any postal delay. The candidate will also be required to write his/her complete correspondence and permanent address with pin code number, cell phone numbers and E-mail ID
5. Mere possession of eligibility conditions shall not entitle a candidate to be called for interview. The date of determining the eligibility of all candidates in every aspect shall be the closing date as prescribed in the advertisement for receipt of the applications. In other words no candidate shall be called for interview if he does not possess the minimum qualification and experience etc., as on the closing date of the application for a particular post.
6. In case of receipt of more number of applications for all/any particular post, the Rashtriya Sanskrit Vidyapeetha, Tirupati reserves the right to increase/fix eligible cut off marks basing on the recommendations of the committee so duly constituted for the purpose for all/any particular post.
7. Acceptance of documents/certificates/claims etc., submitted by any applicant will be subject to their verification by the Competent authority/sources. If, any claim/certificate/document is found to be false/fake/incorrect/malafide at any stage of verification before or after appointment, the document in question shall be summarily rejected and action may be initiated against the candidate for this misconduct including rejection of his candidature which shall lead to cancellation of his appointment, if already appointed.
8. If at any stage of the recruitment process or employment, if it is detected that there is a willful suppression of factual information relating to the eligibility or otherwise as a candidate, followed by supply of fake documents/ or misleading statement/information in the application or tampering of documents or providing such information relating to the caste, educational qualifications, experience, date of birth or domicile etc., the candidate shall be cancelled and the services shall be terminated forthwith.
9. Territorial Jurisdiction: In case of any disputes, the territorial jurisdiction for adjudication shall be the High Court for the State of Andhra Pradesh and Telangana only.
10. Canvassing in any form shall disqualify the candidature of the candidate.
