**ELIGIBILITY :-**

- 1) The candidates for both the posts must be Indian Citizens.
- 2) The candidates for both the posts must read upto Class-Eight.
- 3) Candidates applying for the post of DRIVER must possess a valid Driving Licence issued by the competent authority and must have at least 3 (three) years of driving experience.
- 4) The candidates must not be less than 18 years and more than 44 years of age as on the date of application. Relaxation of age will however be given as per Govt. Rule

**SELECTION PROCEDURE :-**

The candidates for both the posts will have to appear an Interview (Viva-Voce) at their own expense. The selection will be made purely on merit basis. The candidates for the post of DRIVER will have to appear two Tests namely Viva-Voce (45 marks) and Driving Test (5 marks). The candidates for the post of Peon will have to appear Viva-Voce having 30 marks. Canvassing directly or indirectly by any candidate will lead to cancellation of his/her candidature. The appointing authority reserves the right to reject over-qualified candidates in consideration of the number of applications received.
