**1. Scientist B (Non Medical): 1 (one) Post (Unreserved)**

Essential Qualification: 1st Class Masters Degree in Life Sciences/ Molecular Biology/ Biotechnology/ Microbiology/ Bioinformatics from a recognized university with 2 (two) years of research experience in relevant field

Or

2<sup>nd</sup> Class Masters Degree in Life Sciences/ Molecular Biology/ Biotechnology/ Microbiology/ Bioinformatics with PhD Degree in relevant subject from a recognized university.

Desirable Qualification: i) Additional Post doctoral research / training experience in the field of health research and molecular biology (ii) Knowledge of computer applications.

Age limit: 18-35 years

**2. Research Assistant: 1 (one) post (OBC)**

Essential Qualification: Graduate in any subject from a recognized university with 5 (five) years work experience from a recognized institution.


