3. Applications of Candidates who have successfully applied earlier and have completed their applications in all respect (including payment of Rs. 500/-fees, if applicable) will be considered. As specified in our advertisement dated 31st August 2018, it is reiterated that for Non-Exempted candidates only On submission of application fees, the application process will be treated as complete.
