MOIL invites application from energetic & dynamic candidates, who are willing to grow with MOIL in the following categories:

(I) Chief Manager (Mines) (E-04) – 03 Posts [3 UR] (Re-advertisement)

1) Qualification:-

- i) B.E/B.Tech in Mining or equivalent from a recognized University/ Institute.
- ii) 1st Class Mine Manager's Certificate of Competency (U/R) under MMR 1961 from DGMS.

2) Scale of pay: Rs.70,000-3%-2,00,000(E-04).The CTC is around Rs.16.50 Lakhs(approx).

3) Age limit : Below 42 years (relaxable as per Government Guidelines).

3) Age limit : Upto 40 years (relaxable as per Government Guidelines)

4) Experience: 3 years' experience as Winding Engine Driver after getting 2nd Class Winding Engine Driver Certificate of Competency.

Note: Upper age limit may be relaxed in case of experienced Winding Engine Driver for the period equivalent to total period of experience gained as 1st class and 2nd class Winding Engine Driver in any Mining Industry.
