General Terms & Conditions:

- 1. Engagement will be initially for a period of Six Months/One Year depending upon the project requirement, which may be extended or curtailed depending on the duration of the Project/desired level performance or conduct of the incumbent, as the case may be.
- 2. The tenure of Project Staff shall be co-terminus with the project. However, under no circumstances the tenure would be allowed to exceed five years duration. The performance of the Project Staff would be reviewed periodically so that any one not found up to the mark, could be terminated.

On completion of the tenure in one project, in case, one wants to apply for engagement in another project, he/she will have to go through the process of selection by submitting a fresh application under the new project. Engagement of the Project Staff under the new project would be made only after submission of resignation and "No Demand Certificate" in the previous project.
